Before DOI, Subject complained of back pain on X (Twitter) and also went skiing. After DOI, Subject's first post following the DOI is a picture of her in a car. She has also gone out to the bar multiple times. A picture was posted of her on the ground with a dog. Subject has done a lot of traveling (going to Ireland, flying in a plane, going to Phoenix, Arizona, going on a cruise, going to Alabama, the Dominican Republic, Colorado, Greece, and a vacation). She also attended many concerts and festivals between 2021 and 2023. Subject can be seen dressed up for Halloween and posted a 2021 recap of everything she did throughout the year. She also went out to parties and did Pilates and went for plenty of walks. However, she did post about being in the ER, then she posted about talking to her health insurance company, and another post about having back problems. She was seen in a family photo as well as an August recap video she posted. She also attended her friend's birthday party in March of 2023 and is seen in a video singing in the car. Her most recent activity on Facebook was on July 6, 2024, and her most recent Instagram activity was on July 24, 2024. Subject's email address, carolinecreaven10@gmail.com, led to a Google account with reviews. One review was for an emergency center approximately 4 years ago. Another review was for an orthopedic office approximately 2 years ago. There were no mentions of an injury or accident on Subject's accounts or associates' accounts.

Court and Property Records:

Subject's current address is 16210 PELICAN BEACH LN, HOUSTON, TX 77044-1225. Property records for this address could not be found. Please note that Caroline's most recent address history (last two years), was also included in the report. Per the background search, there were 0 bankruptcies, 0 liens, and 0 judgments found for Subject. Multiple court records were found. In 2010, a divorce case was filed between Subject's parents. In 2013, another court case was filed for the divorce, involving the children (Subject and her brothers). In 2016, Subject filed a civil case against her mother, Joyce Creaven. A court of appeals case was filed in 2018 for Subject vs. Joyce Creaven. The last court record found was filed in 2023 for a motor vehicle accident against Guillermo Ramirez.

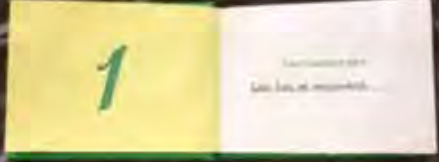

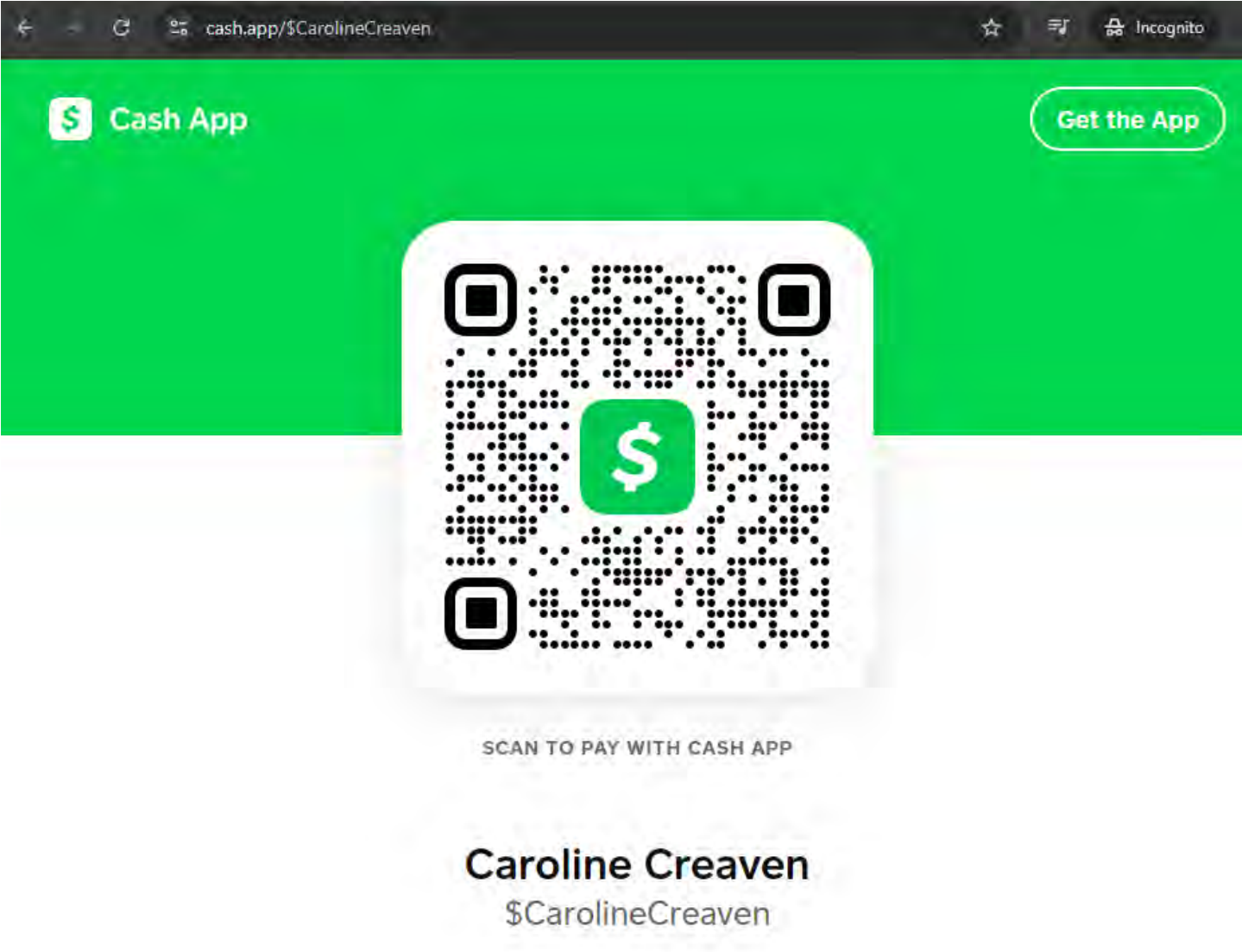

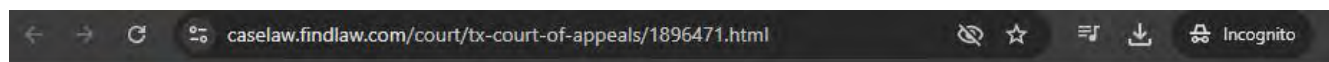

OPINION

This is a tale of three street names. Caroline Creaven sued her mother Joyce Creaven for allegedly improperly withdrawing funds from Caroline's college fund.¹ The trial court granted Caroline's motion for substituted service of process and ordered substituted service. The affidavit in support of the motion, the substituted service order, and the return of service referenced addresses for Joyce with three different but similar street names. After Caroline purportedly served Joyce, Caroline moved for a no-answer default judgment, which the trial court granted. Joyce complains on appeal that the default judgment is void because Caroline did not strictly comply with the terms of the order granting substituted service in that the address in the return of service varied from the address in the order.² Concluding that Caroline failed to create a record reflecting that she served Joyce at the correct address, we reverse and remand.

Caroline's motion for substituted service was supported by her process server's "Affidavit in Support of Motion for Alternate Service" in which the process server attested, on page one, that he attempted to serve Joyce five times at an address on "Cambrian Park Court" in Sugar Land, Texas and, on page two, that he had determined Joyce's "usual place of business, usual place of abode or other place where [she could] probably be found" was at an address on "Cambrian Court" in Sugar Land.³ In its "Order Authorizing Substitute Service" the trial court ordered service to be completed on Joyce at an address on "Cambrian
