Upon arrival, a white 2015 Ford F-250, GA tag #SDV1477, and a purple 2007 Chevrolet HHR, GA tag #SAS1375, both registered to Nina Buchanan, were observed in the driveway. According to the claimant's database report, he have a red 2014 RAM 1500 SLT GA tag #CQX5145 and a green 1993 Ford Explorer XLT GA tag #PVT9994 registered vehicles in his name. The investigator obtained a suitable position on the most likely departure route. Due to lack of claimant activity, surveillance efforts were discontinued at this time.

**Saturday / June 15, 2024 (7:25am – 1:33pm)** Surveillance was resumed at the claimant's address. Upon arrival, a 2007 Chevrolet HHR, registered to the claimant's wife was observed backed in and parked on the property. A white pickup truck, that appeared to be the Ford F-250 which was observed on the previous investigation day and is also registered to the claimant's presumed wife, was partially observed parked, behind obstruction. The claimant has no current registered vehicles in his name. A suitable surveillance position was obtained with view of the only route of departure. The claimant has no current registered vehicles in his name. A suitable surveillance position was obtained with view of the only route of departure.

5:47pm

A male, believed to be the claimant, operating a white Ford F-250 pickup truck, GA tag #SDV1477, registered to the claimant's wife was observed traveling in the direction of the residence. The Ford pick-up truck was parked in front of the residence and the claimant was observed, from the back and through obstruction, entering the residence.

5:48pm

The investigator attempted to obtain video documentation of the claimant; however, the claimant entered the residence behind obstruction. The investigator returned to a suitable surveillance position with view of the only route of departure.

8:45pm

Due to lack of claimant activity, surveillance efforts were discontinued.
