


INVESTIGATIVE SUMMARY

Upon arrival, four vehicles were parked on the driveway and front yard. One vehicle was registered to the claimant, 2016 Red Jeep SUV, registered to Jesus Salazar or Claudia Gil. A Hispanic Male Adult, 40's, exited the front door of the residence. He departed in a Toyota Pickup, which was parked in the yard. Due to lack of observable claimant activity, surveillance was discontinued.


